**Subject:** ASR --> problem with ASR-study!

Dear both,

We experienced a little surprise with our ASR Steering Commitee meeting yesterday..

As you know, dr. Bom has suffered some problems with the ASR lately. He has reported his problems with moving cups, as was discussed with Magnus. Although he seemed satisfied with the discussion, he is still convinced that two moving cups are not explained what happened and that this might be an ASR-problem more then caused by his own surgical technique. The third was sent to Magnus on which he is awaiting the results of research on that cup. Recently, dr. Bom saw two patients in his practice with heavy pain complaints (ASR was placed one year ago). He did not see any significant problem that might have caused these problems. What he did see is high concentrations of metal ion-levels in the blood. I contacted Magnus and asked dr. Bom to send all relevant information, so that is running.

However, yesterday dr. Bom made an official statement during the meeting for the ASR-study. He declared that with his experience with BHR and ASR, his results show a significance in failure rate for ASR. Also he discussed his problems and mentioned the last two patients. Then he mentioned that so far he will NOT use ASR anymore for this reason. He is awaiting the results from DePuy and needs a reassuring proof, before he will start again. This is our key opinion leader in the Netherlands, responsible for 100 ASR's per year. We suspect that Finsbury with ADEPT hip (via Oudshoorn distributer) is trying to get Bom as KOL, so we know there are commercial/financial issues playing on a personal level with dr. Bom. However, this is a huge problem for us, as all other ASR users will listen to dr. Bom..

My request to you is as follows:

- Could you please help me in writing a sound statement that what dr. Bom is experiencing is NOT what we see globally?
- Could you advise me in using the correct literature (publications in journals) to provide reassurance to our other ASR-users?
- Could you please advise me in what strategy is best to follow here? (we need our reps to discuss with the docters, profide an official DePuy statement and profide them with written proof of the ASR-success; what else can I do?)

Thanks in advance and looking forward to discuss this with you!
